

MiTECH+ Terms and Conditions

1. The promoter is: Intergas Heating Ltd (company no 6459477) whose registered office is at Unit 2 Easter Park, Worcester Road, Kidderminster, DY11 7AR.
2. The MiTECH+ scheme is operated under Intergas Heating Ltd
3. When the Member applies to become a Member of MiTECH+, they agree that the application and Membership of this Programme shall be governed by these terms and conditions.
4. Membership of MiTECH+ is at the sole discretion of Intergas Heating Limited, and Intergas Heating Ltd shall not be obliged to accept any applications for Membership of the Programme
5. MiTECH+ is not available to persons under the age of 18 and the Rewards may not be redeemed by persons under the age of 18. You are responsible for ensuring that this age limit is strictly adhered to.
6. MiTECH+ is the Intergas loyalty scheme available to Gas safe registered installers whose business is registered in MiREG+ and has completed a full Intergas training course.

8. To be eligible for MiTECH+ an installer must be classified as a loyal installer to the Intergas brand whereby 75% of the businesses overall installs must be Intergas Boilers.
9. Employees and the families of Intergas Heating Ltd and its subsidiary companies, their agents or anyone professionally connected Intergas, are not eligible to participate in this loyalty scheme.
10. This scheme is not available to any businesses that are connected with contract support, contracts and sub-contractors or commercial specification projects.
11. Welcome packs will only be issued once an installer has completed their webpage and has been approved by their area sales manager.
12. If information is not completed within 3 months of joining the scheme, the business will be removed as a MiTECH+ installer.
13. Vouchers issued at the time of joining the scheme will be valid for 12 months only.
